

NORTH COAST SANITATION LLC

Price schedule and Rental agreement:

20 Yard container: \$ 225.00 up to 8 ton. \$50 per ton over 8.

30 Yard container: \$ 275.00 up to 8 ton. \$50 per ton over 8.

(This refers to container rental charges and does not refer to landfill charges)

- Rental includes **up to 14 days** with a \$15 per day charge for each day after 14.
- **All invoices are due upon receipt.** Invoice will be assessed with a late fee of 18% APR 30 days after invoice date. Any invoice delinquent 90 days will be filed for collection in accordance with North Dakota State Law. Any account going to collection will be permanently ineligible for future service with North Coast Sanitation, our partners and affiliates.
- All container rentals are calculated by the weight of the contents regardless of container size.
- Outside of Minot City limits: mileage rate charge of \$2.50 per mile **each trip each way.**
- Wait/work time rate of \$150.00 per hour in 15 minute increments will be charged after the first 30 minutes and will apply to delays within your control and/or obtaining access to and from the work area including the Minot Air Force Base.
- Any container dumped and returned to the same customer constitutes a new rental.
- Landfill charges will include an additional \$1.00 per ton handling charge.

North Coast Sanitation is a **service-for-hire** not a contractor or sub-contractor. North Coast is not responsible for damage arising from placement of a container in any location at the customer's request. This includes but is not limited to cracks, scratches or other damage to driveways, lawn, curb & gutter, roadway edges, sidewalks, walkways, landscaping including sprinkler systems, trees & branches. When placing a container at any location it is the policy of North Coast Sanitation to assume the customer has assessed the area for risk of damage and/or acquired the necessary permission for that location. The customer agrees to hold North Coast Sanitation harmless regarding personal injury, property damage and right-of-way discrepancies. The customer assumes reasonable care for the rented equipment including but not limited to damage from reckless loading or over loading, collision, damage to the property of others and fire damage to containers while in the customer's possession. NEVER allow fire to burn in a container. North Coast Sanitation reserves the right to repurpose or recycle any materials placed within the containers at our discretion unless otherwise agreed in writing. It is never advised to use heavy equipment to load these containers. If/when such equipment is used to load a container the customer should be aware that excessive weight will likely occur and this will directly affect the rental charges. **Never attempt to move containers by pushing on them with heavy equipment.** Any evidence of this will cause the containers to be removed immediately and suspend future service indefinitely.

The customer understands that they will be directly billed for any damage to our equipment caused by themselves, their employee's, sub-contractors or any person authorized to perform duties involving this equipment including but not limited to damage from careless loading or attempts to move our containers.

Insurance: Certificates of proof of liability insurance are available to all customers upon request.

Customers requesting to be listed as Additionally Insured will be required to pay the certificate policy change fee. It is strongly advised that a client wishing to be added as additionally insured make this request in advance of the first container being serviced. Failure to make this request in advance or refusal to pay the policy change fee will not be justifiable grounds to delayed payment.

I hereby declare that I have the authority to accept the terms explained here and I understand that the acceptance and/or use of the equipment and/or my signature on this document serves as my acknowledgement that this is a legal and binding agreement which supersedes any and all documents regarding the services provided by North Coast Sanitation LLC.

Furthermore I accept the responsibility for all charges explained here.
